Whilst HTT is a Registered Training Organisation (RTO) and we abide by the provisions of the **Standards for RTOs 2015**, we also need to meet strict criteria for other agencies such as Department of Transport (DoT) and Main Roads. Therefore, HTT **cannot** guarantee you will be successful unless all your assessment criteria meets the required level of skill & knowledge laid out in the training package requirements for this UoC and the expectations of DoT.

TLIC3005 Drive heavy combination vehicle

Course Details

This **2 day course** will provide the skills and knowledge required to drive a heavy -combination vehicle safely, including systematic and efficient control of all vehicle functions, coupling and uncoupling of trailers, monitoring of traffic and road conditions, management of vehicle condition and performance, and effective management of hazardous situations.

Pre-Requisites & Entry Requirements

To complete the course you will need to ensure you have the following:

- Hold a C class license for at least 3 years, and a HR class license for at least 2 years.
- Access to a PC to complete your theory assessment.
- Read a *learner manual* and complete a **Theory Assessment** in your own time prior to attendance of your 2 day of training.
- Read through all documents provided in a '*Student Information Pack*'.
- Adhere to our dress code: Loose fitting clothing and **enclosed flat shoes** must be worn for the day of training.
- Provide your **Unique Student Identifier**.

Enrolment Process

Once you have made the decision to complete this course, HTT will forward you a '*Student Information Pack*' with all the relevant details about the course and an '*Enrolment Form*'. NB: Your booking will be confirmed on payment of a deposit.

Also included in this pack will be a *Learner Manual* and *Theory Assessment*. The *Theory Assessment* **must be completed** before you arrive for your face-to-face training at our facility in Cockburn.

Fees & Charges

The course fees include all training, assessments and provision of a SoA for **TLIC3005 Drive heavy combination vehicle** for **\$2,500**.

We have a fixed deposit payable on enrolment (\$500), and the balance to be paid in full on scheduled day of training /assessment.

Driving lessons ONLY = \$360 (2-hour blocks)

Duration

- Theory assessment , completed in your own time prior to training (2-6 hrs may take more hours)
- Face-to-face training and practical assessment, conducted over a period of **2-days** in our training facility in Cockburn Central which include 9 hours of practical training (split across two days) and DoT PDA.

Non-competent on the day: Learners, who are deemed not yet competent after their training component are encouraged to continue the learning process with additional driving lessons. (We recommend at least 2 hours of further driving lessons prior to re-assessment).
